New Investment Criteria:

Structure	We are equity investors but can creatively structure our investments in the form of debt or other types of securities.
Amount	We initially invest between \$5 million and \$15 million in platform companies that ideally offer additional equity investment opportunities over time. We are able to complete much larger transactions.
Company Size	EBITDA range of \$2 million - \$15 million.
Geography	In order to remain in close contact with management, we focus on businesses with head offices within three hours travel from Toronto.
Ownership Interest	We prefer to be majority investors. However, we will acquire significant minority interests where we are aligned with management and other shareholders.
